- 1. If you have a small farm, a wood lot, derive any income from cattle, chickens, lumber or corn you can now enter the information for a Schedule F directly during the TaxLogic interview.
- 2. Information for in home office deductions can now be entered through TaxLogic on form 8829. If you meet the stringent requirements for maintaining a home office and are entitled to the deduction we can help work you through the maze of requirements and limitations. If you have questions on it please let us know. A photo of your home office will greatly add to the substantiation of the deduction. - 3. Through http://www.allMyDeductions.com, you can keep track of your contributions and medical expenses throughout the year. This is a free site that we put up this year as an enhancement to our tax wallet in past years. http://www.Allmydeductions.com will allow you to enter all medical bills from credit cards, co pays, prescriptions, cash, checks, bills, etc. You can enter the information at any time and for any year. The other part is charitable contributions. During the year you give clothes to goodwill, cash to the church, checks to non-profits, credit card payments, Telethons and payroll deductions to United Way. Now for the first time you can keep track of all those different payments in one place. http://www.allmydeductions.com at the end of the year you can have a full report of all your charitable giving. The program will keep track of your miles as well those that are deductible for your charitable work. And the best thing is that it is free and part of the TaxLogic advice. In addition, your current email address and password will get you into both sites so no need to remember more passwords and email addresses. Once logged on you can switch between the tax program, charitable giving and medical deductions.
